Explanatory note

This Order is made under section 59 (1) (a) of the *Water Management Act 2000*. The object of this Order is to make an available water determination for various categories of access licences in the water sources identified in Schedule 1.

1 Name of Order

This Order is the *Available Water Determination Order for Various NSW Unregulated and Alluvial Water Sources (No. 1) 2015*.

2 Commencement

This Order commences on 1 July 2015.

3 Available water determination

This Order determines the availability of water in relation to the water sources specified in Schedule 1, for the categories and subcategories of access licence specified in Schedules 2, 3, 4, 5, 6, and 7 on the terms specified in Schedules 2, 3, 4, 5, 6, and 7.

Schedule 1 Water sources

This Order applies to the following water sources:

1. all water sources to which the *Water Sharing Plan for the Bellinger River Area Unregulated and Alluvial Water Sources 2008* applies;
2. all water sources to which the *Water Sharing Plan for the Coffs Harbour Area Unregulated and Alluvial Water Sources 2009* applies;

5. all water sources to which the *Water Sharing Plan for the Lower North Coast unregulated and Alluvial Water Sources 2009* applies;
6. all water sources to which the *Water Sharing Plan for the Murrumbidgee Unregulated and Alluvial Water Sources 2010* applies;
7. all water sources to which the *Water Sharing Plan for the Murray Unregulated and Alluvial Water Sources 2011* applies;
8. all water sources to which the *Water Sharing Plan for the North Western Unregulated and Fractured Rock Water Sources 2011* applies;
9. all water sources to which the *Water Sharing Plan for the Towamba River Unregulated and Alluvial Water Sources 2010* applies;
10. all water sources to which the *Water Sharing Plan for the Tweed River Area Unregulated and Alluvial Water Sources 2010* applies;
11. all water sources to which the *Water Sharing Plan for the Wybong Creek Water Source 2003** applies;
