

## Apply for a rebate

This form is for eligible holders of a Western Lands lease who wish to apply for a rebate for rehabilitation on a:

- temporary basis (for a period of 10 years or fewer); or
- permanent basis (for a period of more than 10 years)

If you are eligible, we grant rebates for the duration of the agreement approved by the department at a rate of:

- \$0.30 per hectare for rehabilitation works on a temporary basis
- \$0.40 per hectare for rehabilitation works on a permanent basis, though rent cannot be reduced below the statutory minimum.

There are no departmental charges for applying for a rehabilitation rebate for a rural Western Lands lease.

All applications are considered on their own merits and are assessed in accordance with the *Crown land financial concessions policy IND-O-254 and Guideline—Crown land financial concessions*.
