Explanatory note

This Order is made under section 59 (1) (a) of the *Water Management Act 2000*. The object of this Order is to make an available water determination for various categories of access licences in the water sources identified in Schedule 1.

1 Name of Order

This Order is the *Available Water Determination Order for Various NSW Groundwater Sources (No. 1) 2017*.

2 Commencement

This Order commences on 1 July 2017.

3 Available water determination

This Order determines the availability of water in relation to the water sources specified in Schedule 1, for the categories and subcategories of access licence specified in Schedules 2, 3, 4 and 5 on the terms specified in Schedules 2, 3, 4 and 5.

Schedule 1 Water sources

This Order applies to the following water sources:

1. All water sources to which the *Water Sharing Plan for the Lower Gwydir Groundwater Source 2003* applies;
2. All water sources to which the *Water Sharing Plan for the Lower Lachlan Groundwater Source 2003* applies;
3. All water sources to which the *Water Sharing Plan for the Lower Macquarie Groundwater Sources 2003* applies;
4. All water sources to which the *Water Sharing Plan for the Lower Murray Groundwater Source* applies;
5. All water sources to which the *Water Sharing Plan for the Lower Murrumbidgee Groundwater Sources 2003* applies;
6. All water sources to which the *Water Sharing Plan for the Upper and Lower Namoi Groundwater Sources 2003* applies.

Schedule 2 Domestic and stock access licences

Each amount specified in Column 2 applies to domestic and stock access licences with a share component that specifies the adjacent water source specified in Column 1.
