## **Explanatory note**

This Order is made under section 59 (1) (a) of the *Water Management Act 2000*. The object of this Order is to make an available water determination for various categories of access licences in the water sources identified in Schedule 1.

## 1 Name of Order

This Order is the *Available Water Determination Order for the North Coast Coastal Sands and the North Coast Fractured and Porous Rock Groundwater Sources 2017*.

## 2 Commencement

This Order commences on the 1<sup>st</sup> July 2017.

## 3 Available water determination

This Order determines the availability of water in relation to the water sources specified in Schedule 1, for the categories and subcategories of access licence specified in Schedules 2, 3 and 4, on the terms specified in Schedules 2, 3 and 4.

### Schedule 1 Water Sources

This Order applies to the following water sources:

1. All water sources to which the *Water Sharing Plan for the North Coast Coastal Sands Groundwater Sources 2016* applies; and
2. All water sources to which the *Water Sharing Plan for the North Coast Fractured and Porous Rock Groundwater Sources 2016* applies

### Schedule 2 Local water utility access licences

Each amount specified in Column 2 applies to local water utility access licences with a share component that specifies the adjacent water source specified in Column 1.

<b>COLUMN 1</b> <b>Water source/s</b>	<b>COLUMN 2</b> <b>Percentage per megalitre of access licence share component</b>
North Coast Coastal Sands Groundwater Sources	100%
North Coast Fractured and Porous Rock Groundwater Sources	100%

### Schedule 3 Major utility access licences

Each amount specified in Column 2 applies to major utility access licences with a share component that specifies the adjacent water source specified in Column 1.

<b>COLUMN 1</b> <b>Water source/s</b>	<b>COLUMN 2</b> <b>Percentage per megalitre of access licence share component</b>
North Coast Coastal Sands Groundwater Sources	100%

### Schedule 4 Aquifer access licences

Each amount specified in Column 2 applies to aquifer access licences with a share component that specifies the adjacent water source specified in Column 1.

<b>COLUMN 1</b> <b>Water source/s</b>	<b>COLUMN 2</b> <b>Volume per unit of access licence share component</b>
North Coast Coastal Sands Groundwater Sources	1.0 megalitre
North Coast Fractured and Porous Rock Groundwater Sources	1.0 megalitre

Notes: (1) An available water determination made in relation to a particular category of access licence applies to all subcategories of that category, except to the extent to which this order provides otherwise, in accordance with section 59 (1A) of the *Water Management Act 2000*.
