This Order is made under section 59 (1) (a) of the *Water Management Act 2000*. The object of this Order is to make an available water determination for various categories of access licences in the water sources identified in Schedule 1.

## 1 Name of Order

This Order is the *Available Water Determination Order for the Murrumbidgee Regulated River Water Source 2020-21 [No. 12]*.

## 2 Commencement

This Order commences on the 15<sup>th</sup> December 2020.

## 3 Available water determination

This Order determines the availability of water in relation to the water source specified in Schedule 1, for the categories and subcategories of access licence specified in Schedules 2, 3, 4 and 5 on the terms specified in Schedules 2, 3, 4 and 5.

### Schedule 1 Water sources

This Order applies to the following water sources:

1. all water sources to which the *Water Sharing Plan for the Murrumbidgee Regulated River Water Source 2016* applies;

### Schedule 2 Regulated river (general security) access licences

Each amount specified in Column 2 applies to regulated river (general security) access licences with a share component that specifies the water source specified in Column 1.
