Explanatory note

This Order is made under section 59 (1) (a) of the *Water Management Act 2000*. The object of this Order is to make an available water determination for various categories of access licences in the water sources identified in Schedule 1.

1 Name of Order

This Order is the *Available Water Determination Order for the Nambucca Unregulated and Alluvial Water Sources 2016*.

2 Commencement

This Order commences on the day in which it is signed.

3 Available water determination

This Order determines the availability of water in relation to the water sources specified in Schedule 1, for the categories and subcategories of access licence specified in Schedules 2, 3, 4 and 5, on the terms specified in Schedules 2, 3, 4 and 5.

Schedule 1 Water Sources

This Order applies to all water sources to which the *Water Sharing Plan for the Nambucca Unregulated and Alluvial Water Sources 2016* applies.

Schedule 2 Domestic and stock access licences

Each amount specified in Column 2 applies to domestic & stock access licences with a share component that specifies the adjacent water source specified in Column 1.

Nambucca Unregulated and Upriver Alluvial Water Sources	200%
Coastal Nambucca Floodplain Alluvial Groundwater Source	100%

Schedule 3 Local water utility access licences

Each amount specified in Column 2 applies to local water utility access licences with a share component that specifies the adjacent water source specified in Column 1.

Coastal Nambucca Floodplain Alluvial Groundwater Source	100%

Schedule 4 Unregulated river access licences

Each amount specified in Column 2 applies to unregulated river access licences with a share component that specifies the adjacent water source specified in Column 1.

Nambucca Unregulated and Upriver Alluvial Water Sources	2.0 megalitre

Schedule 5 Aquifer access licences

Each amount specified in Column 2 applies to unregulated river access licences with a share component that specifies the adjacent water source specified in Column 1.

Water source/s	Volume per unit of access licence share component
Nambucca Unregulated and Upriver Alluvial Water Sources	2.0 megalitre
Coastal Nambucca Floodplain Alluvial Groundwater Source	1.0 megalitre
