

Landowner's consent for domestic waterfront structures application

Use this form to seek landowner's consent for domestic waterfront structures for lodgement of applications to other approval authorities* in respect of development proposals on Crown land.

Important information

The Department of Planning, Industry and Environment—Crown Lands (the Department) has the authority to grant minister's consent as landowner under the *Crown Land Management Act 2016* to the lodging of:

- development applications, Complying Development Certificate applications, Building Information Certificates and major project applications under the *Environmental Planning and Assessment Act 1979*
- development applications under the *Native Vegetation Act 2003*
- applications required under other applicable legislation.

Landowner's consent will only be given if it is determined that the proposal is consistent with the management of Crown land under the *Crown Land Management Act 2016*. Crown land includes waterway areas.

If your proposal requires the lodgement of a Development Application (DA) with council, the completed DA in its entirety, must be forwarded to the department for the provision of land owner's consent prior to lodgement with council

* Approval authorities include Council, Fisheries, Maritime, the Minister for Planning, other government agencies, or an accredited certifier for the issue of a Complying Development Certificate. You should make your own enquiries as to the type of application, if any, you need to make.

 - i. title block, border, scale, key, boundary dimensions, site area, north point and, where applicable, vertical datum and contours;
 - ii. location and use of existing structures, including any reclaimed area and free standing piles below Deed Mean High Water Mark;
 - iii. the position of the Mean High Water Mark in relation to the registered deposited plan boundaries;
 - iv. the distance from the side property boundaries to the existing and proposed structures
 - v. the calculated areas (m²) for each structure or reclamation below the Deed Mean High Water Mark
- Attached the plans or drawings describing the proposed development. It must be overlaid on the Identification Survey and indicate:
 - i. the location of the proposed development (including extensions or additions to existing structures) in relation to the site boundaries and adjoining development;
 - ii. elevations and sections showing proposed materials, external finishes and heights
 - iii. the calculated areas for each structure or reclamation below the Deed Mean High Water Mark

Incomplete applications:

Any applications received by the department that are missing required documentation, fees, application forms, plans or approvals from other agencies may be rejected or returned to the applicant as incomplete.
