## **Explanatory note**

This Order is made under section 59(1)(a) of the *Water Management Act 2000*. The object of this Order is to make an available water determination for various categories of access licences in the water sources identified in Schedule 1 of this Order.

## **1 Name of Order**

This Order is the *Available Water Determination Order for the NSW Murray and Lower Darling Regulated Rivers Water Sources 2016*.

## **2 Commencement**

This Order commences on the 15<sup>th</sup> January 2016.

## **3 Available water determination**

This Order determines the availability of water in relation to the water sources specified in Schedule 1, for the categories and subcategories of access licence specified in Schedules 2, 3 and 4 on the terms specified in Schedules 2, 3 and 4.

## Schedule 1 Water Sources

This Order applies to the following water sources:

1. all water sources to which the *Water Sharing Plan for the NSW Murray and Lower Darling Regulated Rivers Water Sources 2003* applies;

## Schedule 2 Domestic and stock access licences

Each amount specified in Column 2 applies to domestic and stock access licences with a share component that specifies the adjacent water source specified in Column 1.

<b>COLUMN 1</b> <b>Water source/s</b>	<b>COLUMN 2</b> <b>Percentage per megalitre of access licence share component</b>
Lower-Darling Regulated River Water Source	25%

## Schedule 3 Local water utility access licences

Each amount specified in Column 2 applies to local water utility access licences with a share component that specifies the adjacent water source specified in Column 1.

<b>COLUMN 1</b> <b>Water source/s</b>	<b>COLUMN 2</b> <b>Percentage per megalitre of access licence share component</b>
Lower-Darling Regulated River Water Source	10%

## Schedule 4 Regulated river (high security) access licences

Each amount specified in Column 2 applies to regulated river (high security) access licences with a share component that specifies the adjacent water source specified in Column 1.

<b>COLUMN 1</b> <b>Water source/s</b>	<b>COLUMN 2</b> <b>Volume per unit of access licence share component</b>
Lower-Darling Regulated River Water Source	0.25 megalitre

Notes: (1) An available water determination made in relation to a particular category of access licence applies to all subcategories of that category, except to the extent to which this order provides otherwise, in accordance with section 59 (1A) of the *Water Management Act 2000*.
