<p>This water source includes the Bega River Estuary and several smaller tributaries, such as Jellat Jellat Creek, that flow directly into the estuary. The cumulative hydrologic stress for this water source is the sum of all entitlement in the Bega Valley, and is therefore rated as HIGH. However, since the tidal pool in the Bega Estuary is small, and there is little scope for pumping from the estuary itself, the rules in this report card relate to the small tributaries. The proposed trading rules aim to protect Penooka and Betunga Swamps with the establishment of management zones</p>
