

## Former Perpetual Lease: Removal of restrictions on use

This form should be used to apply for the removal of restrictions on use of former perpetual lease land subject to a restriction under Part 4A of the *Crown Lands Act 1989*, pursuant to s.77A.

### Important information

Properties that are NOT adjoining or within 100 metres of National Park Estate land are eligible for application to remove the s.77A restrictions on use. It is advisable to contact the Landscape Services Centre to confirm eligibility prior to submitting an application and fees.

### Fee
