

## Review of water sharing plans under Section 43A of the Water Management Act 2000

NSW water sharing plans are valid for 10 years from their commencing date. Near the end of the ten-year term, a formal review is completed by the Natural Resources Commission to identify the necessary alterations to deliver better outcomes for water users, including the environment.

The current schedule for plan reviews required under S43A of the *Water Management Act 2000* can be found below. Note: timing for reviews may change where plans are replaced.
